**WHEREAS**, his dedication and skill in performing his duties has helped the District guarantee reliable service to its customers, and


**WHEREAS**, upon the occasion of his departure from employment with the District, the Board of Commissioners wishes to express its great appreciation for his outstanding service;


**NOW, THEREFORE, BE IT RESOLVED** as follows:


