Resolution No. 95-790

A RESOLUTION of the Board of Commissioners of Lakehaven Utility District, King County, Washington, providing for a hearing January 4, 1996, on petitions to annex certain areas of the District known as "52nd Avenue South/South 284th Street".

WHEREAS, there has been addressed to and filed with the Board, a petition signed by the owners of not less than 60 percent of the area of land in the area described therein, contiguous to Lakehaven Utility District, King County Washington, requested annexation to the District, accompanied by plats which outline the boundaries of said property, an area referred as "52nd Avenue South/South 284th Street", described on Exhibit "A", attached hereto and by this reference made a part hereof; and






WHEREAS, it has been proven to the satisfaction of the Board that the petitions comply with the requirements of law, and

NOW, THEREFORE, **BE IT RESOLVED** as follows:

1. A hearing on annexation of realty described on "**Exhibit A**", attached hereto, for annexation to Lakehaven Utility District will be held at Lakehaven Center, 31531 1st Avenue South, Federal Way, Washington, on January 4, 1996, at 8:00 p.m.
2. The Secretary of this Board is authorized and requested to cause notice of the hearings to be published in one issue of a newspaper of general circulation in the area, also the District staff shall post the notices in three public places within the areas petitioning for annexation. Said notices shall also include an invitation to interested person to appear and voice approval or disapproval of the annexation.
3. The District staff is authorized and requested to submit any required notices or application to King County, the King County Boundary Review Board and any other affected agency.
4. The District Staff is authorized and required to prepare any necessary SEPA documents.
