## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Lakehaven Utility District from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Billings/receivables
- Cash receipting
- Open public meeting minutes
- Payments/expenditures
- Procurement (bidding)
- Payroll/personnel

## INFORMATION ABOUT THE DISTRICT

The Lakehaven Utility District provides water and wastewater services in King and Pierce counties. The District encompasses an area of approximately 35 square miles with a service population of approximately 112,000 citizens including most of the city of Federal Way and small portions of the cities of Auburn, Pacific, Tacoma, Des Moines and Milton. In addition, the District serves an unincorporated area of King County which is approximately 18 square miles and is located north of Federal Way and west of Auburn.

An elected five-member Board of Commissioners governs the District. The Board appoints a General Manager to oversee the District's daily operations as well as its nine employees. For fiscal year 2014, the District operated on an annual operating budget of approximately \$26.3 million, including debt service.
